The Community College of Allegheny County is inviting your institution to submit a quote for a tax exempt loan or lease/purchase agreement to fund the acquisition of computers.

- I. The principle amount of the loan will be approximately \$1,600,000 +/-
- II. The term of the tax-exempt loan or lease/purchase agreement will be for 48 months with a commencement date beginning in March 2023 and ending in February 2027.
- III. The agreement for 48 months will be for Continuing Disclosure Reminder Memo level payments totaling \$428,314 per year.
- IV. Please quote the following information for a tax exempt loan or lease/purchase agreement.
 - A. Tax exempt finance rate
 - B. Monthly payments as described in item III.
 - C. Adjustment of Rental Amount Prior to Lease Closing:
